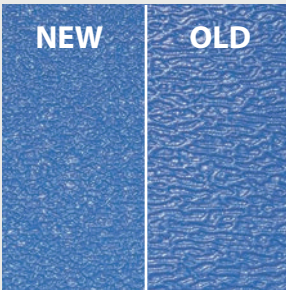

Environmentally-friendly compound

Acrovyn 4000 wall guards and wall coverings are manufactured from engineered PETG, which contains no PBTs (persistent bioaccumulative toxins). Completely free of PVC and BPA (bisphenol A), Acrovyn 4000 has earned Cradle to Cradle® Gold Certification and meets the California 01350 protocol for good indoor air quality.



Contemporary texture

In a customer survey, designers and owners overwhelmingly preferred a less aggressive texture over that of original Acrovyn. Our wall guards are supplied with Shadowgrain texture, a less pronounced texture that allows for easy cleaning while still hiding abrasions. And, our rigid sheet is supplied with Suede texture, an even less pronounced texture similar to a painted surface.



Same impact strength and fungal resistance

This PETG material has been modified to offer impact strength comparable to original Acrovyn and complies with ASTM F476 provisions. Testing has also proven Acrovyn 4000 resists the growth of bacteria and fungi, therefore an antimicrobial agent is not necessary.



Same UL Class 1 fire rating

Just like original Acrovyn, Acrovyn 4000 is a UL Classified and Labeled Class 1 fire rated product. Our UL label means UL biannually checks our manufacturing processes and material to confirm we continue to supply material that is consistent with our original UL test results.

We've given the Acrovyn color palette a face lift just in time for the Acrovyn 4000 release. Also, our Chameleon faux wood and metal patterns are available PVC-free and Cradle to Cradle Certified Silver! We were even able to keep the gloss level of this new non-PVC material the same as original Acrovyn.

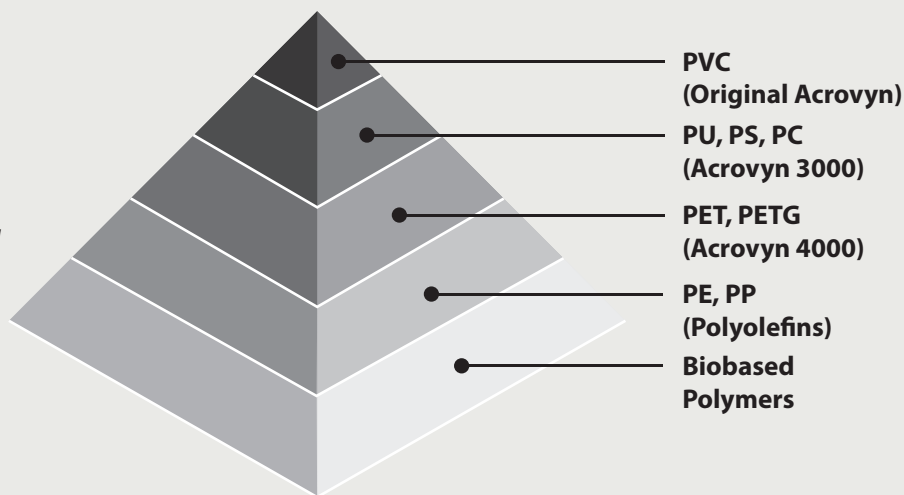
